The two ships are close enough for divers to touch at the same time.

## SRly tops in goods, passenger services

Chennai, Sept 16: Southern Railway's Chennai Division has introduced "Time-tabled container train services" to extend efficient loading and unloading of goods from industries and firms to destinations across the country.

Apart from coal and coke, other major commodities such as fertilisers, gypsum and limestone have been loaded in recent times

The time-tabled container services were introduced in the division for the first time on August 20, and have been running daily between Chennai Harbour and Whitefield near Bengaluru. Each way trip fetches a revenue of Rs 4.3 lakh for the Railways, according to a Southern Railways press release.

The Chennai Division loaded its first rake with Muriate of Potash (MOP) of Indian Potash Limited to Gudivada in Andhra Pradesh. The rake left Chennai Harbour on September 7 with 1,338 tonnes of MOP generating revenue of Rs 9.57 lakh for Railways. Till date, a total of 2,667 tonnes of the consignment has been loaded, earning a revenue of Rs 20 lakh.

#### Safer train journeys

Southern Railway has introduced 13 pairs of intra-state trains after temporary suspension of intra-state trains as requested by the Govt of Tamil Nadu and they are originating and terminating from Dr MGR Chennai Central and Chennai Egmore - two important terminals serving Chennai city.

The extension of train services to Chennai has brought in an increase in the patronage of train services as compared to the patronage that earlier train services enjoyed when it was not touching Chennai but ran upto Arakkonam or Chengalpattu. Similarly, 7 pairs of special mail/express trains are

being run in the State of Kerala. Southern Railway has taken several steps to ensure safe travel for passengers during COVID Pandemic. Only passengers with confirmed tickets and those who are asymptomatic are only allowed to travel. Thermal screening of passengers is done at the entry point itself. Regular sanitization of coaches, toilets are being done at terminals.

In addition to this several modifications have been done in the airconditioning parameters to ensure safe journey of passengers in Air - Conditioned coaches also. Guidelines issued by Ministry of Health, Family welfare and Railway Board are being strictly followed and adhered to in all aspects.

As a safety precaution, Linen is no longer provided to passengers and as such, the temperature of the LHB AC coaches has been increased from the usual 23 degrees to 25 degrees Celsius using the microprocessor Controlled Unit in the AC Coaches so that the passengers are comfortable. In Non-LHB AC coaches, Electronic thermostats have been modified with a setting of 24 to 26 deg C.

#### **Quality of Air**

The quality of air inside the AC Coaches are ensured through Air sanitization. By regular cleaning and sanitization of filters the quality of Air is maintained. These are cleaned during maintenance after every trip. During Periodic Over Hauling, AC ducts of all coaches are cleaned using Robotic procedure.

Thus it can be seen that with the train services including AC coach services in Southern railway being restored in a phased manner with the lifting of lockdown, all measures are being taken to keep the AC coaches in compliance with the stipulations of safety protocols.

### One lakh saplings to honour environmentalist

Coimbatore, Sept 16: Farmers across 20 districts in Tamil Nadu began planting 1.26 lakh saplings in memory of 'Maram' (tree) Thangasamy Aiya, a farmer and wellknown environmentalist.

The planting programme is Cauvery Calling's tribute to one of Tamil Nadu's most farmers and Arignar Anna awardee, who died on September 17, two years ago.

The event began in Senthakudi village in Pudukkottai to mark the day where his son Thanga Kannan participated as the chief guest.

Saplings are being planted across 45 locations in a total of 331 acres

The lockdown has been a revelation and the only way was to



It was the first movie he edited to be released on this platform and it did well too, being a murder-mystery, Prasad said. Another ongoing project is 'Aadujeevitham' (Malayalam) directed by Blessy and starring Prithviraj Sukumaran. During the lockdown, he also launched a 'learning every day' channel on youtube to teach students about editing and

filmmaking.
